RESOLUTION NO. 57,557 -N.S.

AUTHORIZING ALLOCATION OF \$1,500,000 FROM THE PUBLIC EMPLOYMENT RETIREMENT SYSTEM (PERS) REFUND FOR CAPITAL IMPROVEMENT PROJECTS FOR PARKS AND RECREATION CENTER IMPROVEMENTS.

WHEREAS, as part of the FY93-94 budget process, the Council of the City of Berkeley identified \$1,500,000 from the PERS refund to be allocated in FY94-95 for parks Capital Improvement Projects; and

WHEREAS, the Council of the City of Berkeley requested the Parks and Recreation Commission identify the needs for parks and recreation center improvements and make recommendations for the allocation of the PERS refund monies; and

WHEREAS, the Parks and Recreation Commission received community input on specific improvement projects through public hearings and identified those projects most appropriate for funding.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berkeley as follows:

1. That the following capital improvement projects be funded in the amounts designated from \$1,500,000 of the PERS refund:

- 2. That a Park and Recreation Development Trust Fund be established for the purpose of funding the \$1,500,000 in PERS capital improvement projects.
- 3. That all savings realized from the PERS-funded capital improvement projects that are not at Measure AA sites be reallocated to the Mini Grant Program that would be administered by the Parks and Recreation Commission.
- 4. That the City Manager shall report back to the Council with a recommendation on the procedures to be followed in issuing grants through the Mini Grant Program.
- 5. That any savings which can be realized from those projects also receiving Measure AA funding shall be distributed as follows:
 - * The first priority, up to \$70,000, to the Berkeley Rose Garden
 - * Up to \$61,000 to the West Campus Swim Center
 - * \$3,000 to the Ohlone Mural in Ohlone Park.
- 6. That the City Manager shall report back to Council in the Fall with a revised project implementation schedule but staff should begin working with the Berkeley Albany Soccer Club so that construction may begin in July and the field is ready for use in the Spring of 1995.
- 7. That the Council is committed to find funding for restrooms in the Civic Center Area.
